**BACKGROUND:** Based on the recommendation of the Insurance Committee, the Purchasing Department solicited for an employee benefits consultant through a Request for Proposal, and on December 1, 2021, opened sealed proposals. On December 7, 2021, the selection committee (Thomas Dettman, Kathy Haley, and John Shoop) evaluated and ranked all proposals submitted, with Gehring Group, McGriff, and Acentria Public Risk being the three top ranked firms respectively. On December 14, 2021, these firms were interviewed by the committee. To ensure a complete and accurate evaluation, the committee requested additional information and references were checked by staff. On March 25, 2022, the evaluation committee ranked the firms based on the results of the interviews and all information received including the references, with the Gehring Group being ranked the highest firm (see attachment A).

<u>STAFF RECOMMENDATION:</u> Staff recommends awarding the contract for Employee Benefits Consultant to Gehring Group.

<u>REQUESTED MOTION</u>: Approve staff's recommendation, instruct staff to negotiate the terms of the agreement, and instruct the City Attorney to prepare the contract once negotiations are finalized.
