The purpose of this addendum is to provide clarification of the specification and to address questions submitted to the County by prospective Proposers.

Q. With respect to below requirement, does the County actually want to see all these columns when entering their budget requests or is this more of a reporting requirement eg. Being able to print a report with all this information.

1. Pg 17 3.d. d. Ability to have available, at a minimum, in the upcoming fiscal year budget worksheet:
 - (1) Prior two (2) year's modified budget and actual data
 - (2) Current year adopted budget
 - (3) Current year modified budget
 - (4) Current year actual year-to-date (refreshed from the County's General Ledger when requested)
 - (5) Current year department's projections to year-end.
 - (6) Budget for upcoming fiscal year

A. Most of these items are report issues. #5 & #6 would need to be entry fields in the software. I'm attaching two documents that show what we currently use. The first attachment is a screen shot while in the software that shows history for a specific 'cost center' from the past 5 years (current year included) which covers items #1 – 4 but we would like to see some of this data on our budget reports, also, especially a couple years of actual data. The second attachment (expenditure budget) shows what we currently have available thru our provider but would like to upgrade this report also to show two (2) years Actual data instead of one (1) year. This would apply to the revenue reports, also. I hope this information helps.

Q. Can you please restate the following question explaining and providing an example of what the County is looking for as a response? Pg. 25 – 4.1.a. Provide example flow schematics from at least three (34) Budget Software Solution systems used by a government organization of similar size or larger than the County implemented by the Proposer in the past five (5) years.

We just want to see what the steps are to implement the software; in other words, like a flow chart showing the process, does a team member come help with the set-up and give instruction (preferably in person if possible), etc.
