Addendum for Catawba High School – Baseball & Softball Field Improvements

Specs:

1. Winning Bidder will dispose of all spoils either off site in approved location or at location designated by the Fort Mill School District Director of Maintenance.
2. Remove existing fence from dugout to dugout (including bullpens) and then install new fence posts and reinstall existing fence at end of project.
3. Contractor will utilize home plate/backstop as beginning reference point for establishing and maintaining a ½ - 1% grade of fall for entire field, so that water will shed off of the field towards the outfield and eventually in to adjacent storm drains and storm water retention ponds.
4. Contractor will install stone retaining walls as required for bullpens to create a playing surface that has a miniscule fall in the grade to allow water to shed off.
5. Contractor will ensure that there are no valve boxes or drains in playing field.
6. Contractor will ensure that no water collects/puddles near back stop, in front of dugouts, bullpens or on any portion of field.
7. Timing – Mid May start / End July complete.
8. Contractor is responsible for restoring or replacing any damaged grounds, sidewalks, etc... caused by their crew during field reconstruction.
9. Contractor will remove any trash or debris generated as part of the project and dispose of in designated/approved off site location.
10. Contractor will clean all dirt, clay, mud off of sidewalks and surrounding parking areas caused by their crew and equipment after project completion.
