## Q\&A

Questions submitted to date are answered here:

1) There is a specification for Prime in the asphalt specs, but there is no item set up for it on the bid tab. Should there be an item for Prime Coat on the schedule of values?

Please See revised Bid Sheet with a separate Item for Tack. Prime Coat of the aggregate before paving will not be required. Tack between layers will be as specified.
2) In Item \#9 of the Special Conditions for "Testing", it states that "All tests/inspections shall be the responsibility of the Contractor. The cost for testing shall be paid by the owner." Does this mean that the Owner will employ and pay for an independent testing lab to perform all acceptance testing on the project, but the Contractor will have to arrange all the testing with the independent lab selected by the Owner?

The Town of Bluffton will contract with a testing firm that will be able to provide the required Quality Control Testing. The cost for such service will be paid by the Town. It will be the responsibility of the Contractor to schedule, coordinate, and ensure all required testing is completed in accordance with the specifications and good workmanship. If questions arise, the Contractor must communicate with Owner and Engineer regarding testing.
3) Are there any plans or detail sheets available besides sheet C9.0 "Utility Plan" for Buckwalter Place EC Expansion - Phase 1 dated 03/10/2020? If not, I need the details of the following to know what to price.
a. Storm pipe sizes for pipe runs on the plan view
b. Invert elevations and top of castings for all storm structures
c. Detail for Curb Inlets, Catch Basins, and Manholes.
d. Silt Fence
e. Tree Protection Fencing
f. Types A, E, \& F Inlet Protection
g. Concrete Washout Area
h. Turbidity Curtain
i. Temporary Rock Check Dam
j. Construction Entrance
k. 12" Concrete Ribbon Curb
l. 18" Concrete Roll Curb
m. Concrete Sidewalk (thickness?, plain concrete?)
n. Concrete Bollard
o. 6' Wooden Security Fence
p. Brick Column
q. Aluminum Slide Gate
r. Slide Gate Operator (The gate controls in the specs appear to be for swing gates)

See attached updated plans. 6' wood security fenced should be painted with highest quality oil-based Sherwin Williams or approved equal paint. Color to match the windows at the Law Enforcement Center (Patrician Bronze). Assume one coat of oil-based prime and one coat of oil-based paint.

Bricks should be Savannah Grey by Old Carolina Brick Company. Grout color should be ivory buff. The finish on the brick columns to be raked with a $1 / 2$ " motor joint and running bond.
4) Is the striping paint or thermo?
