Addendum #01 August 2, 2022

IFB 23-B0001 Police Vehicle Equipment and Installation

The purpose of this Addendum #01 to IFB 23-B0001 for Police Vehicle Equipment and Installation, dated July 21, 2022, is to answer the following questions:

- 1. On the price schedule, lines 142 145 reference "Equipment Transfer." Are you looking for the removal of all equipment from one vehicle and reinstall in a new vehicle? There may be some equipment from older model vehicles (ex: Tahoe) that may not fit into newer vehicles.
 - Yes, "Equipment Transfer" means to remove all the equipment from an old vehicle and reinstall into a new vehicle. Any equipment that cannot transfer into a newer model vehicle will be discussed with City personnel prior to any work being completed.
- 2. In previous iterations of this contract, tax was to be added at the time of invoice. The current specifications call for tax to be calculated as part of each line item. Please clarify.
 - The first paragraph on page 27 of the bid document clearly states, "Completed vehicle modification bids shall be priced at total cost that includes, but is not limited to: labor, taxes, and fuel costs, as well as necessary parts, such as: wiring, hardware, clips, plates, brackets, cables, etc." Therefore, Line 119 through Line 147 on the price schedule should include a total cost that encompasses all parts, labor, tax, and costs associated with a complete job. If the City orders only parts (Line 1 through Line 118) without any labor or installation, then tax may be added at time of invoice for parts ordered separately.
- 3. It has always been parts individual line and labor as a line itself. Complete Modification is a different one.
 - In an effort to streamline processes, Line 119 through Line 129 on the price schedule are labeled as "Complete Modification" to include all labor, parts, taxes, costs, etc. into one price. On page 43 of the bid document, the third sentence in the first paragraph under "Pricing" should read, "Lines 119 through 129 of the Price Schedule should include "out-the-door" pricing to include all

parts/equipment listed in these specifications, according to the vehicle, as well as, if applicable, the customer supplied radios, cameras, radars, and tab docks."

4. As per section 7.01 of the terms and conditions, do you want the literature for all the manufacturer-specified products submitted with the bid?

No, it is not necessary to submit literature for all the manufacturer-specified products with the bid. However, vendors must be prepared to submit any/all literature immediately upon request of the City.

5. The part number for Line 15 on the price schedule has changed from HINT-TM-5126-PIU-20 to 500-

Yes, this change is acceptable to the City.

6. The part number for Line 83 on the price schedule has changed from WHE-PELCB to WHE-PEL2B.

Yes, this change is acceptable to the City.

7. Line 25 on the price schedule has been discontinued.

Vendors should mark "N/A" on the price schedule for Line 25. An acceptable alternative will be negotiated with the awarded vendor at a later date.

No additional questions will be received. Vendors who have already submitted a bid may submit an updated bid in response to this addendum by the new deadline listed below.

Sealed bids will now be due no later than Monday, August 8, 2022 at 3:00PM (local time.) No electronic submissions will be accepted. The City is not responsible for late or misdirected mail.
