DELINQUENT TAXES:

Interest will be added to any delinquent taxes at a rate of ½% from December 16, 2020, through December 31, 2020, and 1% per month beginning January 2021.

<u>IMPORTANT:</u> When paying property taxes in person, please bring this notice with you. If you mail your property tax payment, please write the receipt number on your check.

Tax notices are mailed to the property owner of record as of January 1, 2020. If you receive a notice but have sold your property, or if your taxes are paid by a mortgage company or someone else, please forward this notice to the person(s) responsible for payment.

You may qualify for tax relief if your City of Columbia home was your primary residence in 2020 and you provide proof of the following requirements:

State of Tennessee Tax Relief for seniors or TOTALLY AND PERMANENTLY disabled:

• Elderly: You were 65 years old (or older) as of December 31, 2020

-OR-

• **Disabled:** You must be totally and permanently disabled as rated by the Social Security Administration or other qualified agency

- AND -

• The total 2019 income from you, your spouse (whether he or she is on the deed or not) and of all persons on the deed did not exceed \$30,700.

State of Tennessee Tax Relief for totally & permanently disabled veterans / surviving spouse of disabled veteran:

• Proof from the Veteran's Administration that veteran is totally & permanently service related disabled.

• For New Applicants: Complete form F-16 or F-16S (copies available at City Hall)
