THIS ADDENDUM FORMS A PART OF THE CONTRACT DOCUMENTS AND MODIFIES THE ORIGINAL BIDDING DOCUMENTS FOR THE REFERENCED PROJECT DATED NOVEMBER 19, 2015.

The following items of the contract documents are modified as part of this addendum:

(1) **Epps Bridge Pump Station Wetwell Cleaning**

- a. Section 01025, Article 3.03: Vacuum truck rental services are not included in the lump sum price for the Epps Bridge Road Pump Station (Bid Item No. 3).
- b. Sheet 7, Scope of Work - Epps Bridge Road Pump Station, Item 2.A: Cleaning of the wall and other remaining materials within the wetwell shall be scheduled so that the total time for vacuum truck rental services, to include vacuum truck travel to and from the site, shall not exceed eight (8) hours.
- c. Sheet 7, Scope of Work - Epps Bridge Road Pump Station, Item 2.A: CONTRACTOR will have the option to dispose cleaning solids at Oconee County's Calls Creek Water Pollution Control Plant. The County will not require any fees for disposing solids generated during the wetwell cleaning.
- d. Section 00300, Bid Form, is revised to include new bid item 6.
- e. Section 01025, Measurement and Payment, is revised to include the following new item:

3.07 WETWELL SOLIDS REMOVAL

The basis of payment for this item shall be a lump sum allowance to include the cost of providing a vacuum truck for removal and disposal of solids created from cleaning of the wall and other remaining materials within the interior of the Epps Bridge Road Pump Station wetwell. All incidental overhead/processing/handling costs incurred by the CONTRACTOR related to the vacuum truck services shall be included in the lump sum price bid for the Epps Bridge Road Pump Station.

(2) **Epps Bridge Road Generator Abandonment (Sheets 3, 7 and E-2)**

- a. CONTRACTOR shall disconnect generator and cap existing gas service. Gas supply abandonment shall be coordinated with the gas supplier and be conducted in accordance with the gas supplier's recommendations.
- b. Constellation Energy (Tel: 877-677-4355) is the natural gas supplier.

- (3) A copy of the project's pre-bid meeting sign-in sheet is attached. There are no minutes associated with this meeting.
