Response to Bidder Questions:

9. Question:

The transformer and pad are shown on electrical drawings, but not located in its actual location.

Response: The transformer shown on E102 is shown in the approximate location. AS101 is updated to match E102. If additional information is required to locate the transformer and pad, this will be coordinated during construction.

10. Question:

A 250 AMP panel is shown. Should you consider upgrading to a 400 AMP panel due to 'future' fans?

Response: 250 AMP service is sufficient for this building and up to four future fans; no change.

11. Question:

Should you consider adding 4 spare breakers for future fans?

Response: Spare breakers are accounted for in the documents; no change.

12. Question:

What feeds the new transformer?

Response: Anderson County Schools will provide primary conduit connection to the new transformer. This change is reflected in Addendum 03 – see E102, E201.

13. Question:

Exit lighting, bathroom lights are on the same circuit – is this allowable by code?

Response: No change. There are no known code issues with the current design.

14. Question:

No PIV shown for sprinkler system.

Response: No change. A wall PIV is shown on the electrical drawings.

15. Question:

For 208V control panel – should we have a relay panel or contactors?

Response: No change. We have specified a lighting control panel with two pole relays.

16. Question:

Can you provide the current fire alarm monitoring company name and contact?
