**Addendum #01

Myrtle's Market Concrete**

The purpose of this Addendum #01 to IFB 19-B0013 for Myrtle's Market Concrete, dated July 31, 2018, is to clarify specifications:

- Concrete is to be poured around light poles and trees. Only sign posts will be moved.
- City will be responsible to mark the irrigation line.
- City recognizes that there will be a valley in the concrete driveway, with a run-off for water.
- The edges of the driveway must be flush with existing concrete pads. At no point can there be any trip hazards due to elevation differences between existing and new concrete.
- The front sidewalk must be poured to meet the asphalt, which means the front sidewalk may be more than five (5) feet wide.

In addition, the attached revised price schedule reflects the changes in sidewalk width.
