CLARIFICATIONS

Q1. Is this an in-person classroom, virtual classroom, or hybrid classroom?

A1. **Mostly in-person classroom. Coaching can be hybrid**

Q2. Roughly how many children shall be supported?

A2. **It depends on the number of children enrolled in the classroom.**

Q3. How many children are in a classroom?

A3. **The facilities follow Child Care Regulations Ratios in Minimum Standards.**

Q4. Under the section of Evaluation Criteria section A it notes based on evidence of qualifications as listed in the proposer's packet. Can you please clarify what is meant by proposer's packet and where one can locate this packet?

A4. **Your response to this solicitation is your proposer's packet.**

Q5. Can you please clarify which Workforce Solutions board(s) fall under this RFQ?

A5. **Greater Dallas, Heart of Texas, Southeast Texas**

Q6. Can you please clarify how many coaches are planning to be trained? This is helpful to determine the roll out sequence and cohort planning.

A6. **Minimum of one and no more than five.**

Q7. Under the timeline section it is noted that you plan to implement 3, -5-week cycles throughout the year beginning in August 2024. Can you please clarify if the plan is to have each classroom participate in 3 five- week cycles, or will they have 3, -5-week cycles with different classrooms?

A7. **Each cycle lasts 5 weeks. The participating programs will participate in three five-week cycles over a year. The participating program must complete a minimum of one cycle and can elect to participate in the other two. If programs elect not to participate in the other cycles the organization will recruit other programs to participate.**

Q8. Can you tell us when questions will be responded to and where they will be posted?

A8. **An Addendum will be sent out no later than 7/19/24. The Addendum will be uploaded to the Texas Smartbuy, Vendor Registry websites and sent directly via email to the emails we have on file.**

Q9. How many classrooms does CCG anticipate participating in the program?

A9. **Twenty (20), but could possibly be more.**
