Modifications to Bid Documents: Replace Drawing A2.13 with attached A2.13 dated September 11, 2020

Pre-Bid Meeting Notes:

The following firms were identified as in attendance at the Zoom pre-bid: Barth Construction Environmental Holdings Bill Bryant and Associates TGSV Hedrick Brothers Construction De La Hoz Builders, Inc.

Purchasing Manager Jennifer Hyde provided guidelines regarding procedures to ask questions and submit bids. Building Official Scott McAdam gave an overview regarding the need for the project and the importance of phasing and maintenance of operations during construction. Architect Tony Donadio responded to technical questions regarding design.

No electronic bids will be accepted.

Project timeline: Award is anticipated for October 6, 2020.

Laydown/storage: Approximately 20 spaces in the center of the parking lot on the west side of the building will be dedicated for storage containers, including one or more for storage of furnishings. No interior building space is identified as contractor office space.


Or equal canopies may be used, as long as they meet the basis of design, as determined by the Architect. Product for leveling floor in former deli area where drains are removed is up to contractor. American Business Interiors (ABI) will install the modular furniture, but contractor must connect electrical, etc.

Questions and Answers

Could a fire sprinkler and fire alarm layout be provided for this project? Could you provide

- information about the fire company that works or have worked for this building? or if you have a
 preferable fire company that we may want to use for this project?
 Wiginton Corporation has most recently provided these services under purchase orders, but is not
 under formal contract. Selection of subcontractors and vendors is at the discretion of the
 contractor and will not be dictated by the County.
- 2. Could you provide the data company that works or have worked for projects in this building? Gerelcom has most recently performed data services. Their current bid award expires on September 30, 2020 and a new bid has not yet been released for these services. Selection of subcontractors and vendors is at the discretion of the contractor and will not be dictated by the County.
- 3. Could you provide the door access company that works or have worked for projects in this building? No vendor is under contract for these services. The contractor is responsible for all hardware, pull wires, installing the swipe, installing the lock mechanisms, and putting everything together for operation. County and/or a vendor it selects at a later date will tie the system into the lock system for operations. Selection of subcontractors and vendors is at the discretion of the contractor and will not be dictated by the County.
- Will the cost of American Business Interiors' scope of work be included in General Contractor's base bid? Or, will American Business Interiors Inc. be contracted directly by the City? Please clarify.
 The construction budget is estimated at \$1.1 million and does not include the materials provided by American Business Interiors. The County is contracting directly with ABI for those items.
- Please advise if there is an asbestos report available for this project.
 No asbestos survey has been completed. The building was constructed in 2017.
- Specification lists several different manufacturers for carpet tiles and no models. Please clarify approved manufacturer and model type.
 This question will be addressed in Addendum 4.
- Specification lists Daltile 18x18 tile but does not specify a model. Please advise.
 This question will be addressed in Addendum 4.

There are discrepancies in specifications for ceiling tiles: Spec 09511-2.1A.1A lists armstrong square lay-in 1728 as an approved product. However 2.3A thru H lists specifications that do not comply with 1728 tile. The closest to the specs is 1754 which is square lay-in and IRC School standard. The closest to the specs that is tegular is 1732 but the LR is only 0.82. Please provide clarification. This question will be addressed in Addendum 4.
