Bids and/or proposals will not be accepted from any contractor that is not listed below as prequalified. General Contractors must attend the mandatory pre-bid conference/ job walk and be pre-qualified to be eligible. The mandatory pre-bid conference/job walk has not been scheduled at this time. It is anticipated to take place after DSA approval in February or March.

Any mechanical, electrical or plumbing subcontractors, as defined by Public Contract Code § 20111.6, must be prequalified, and all general contractors must use prequalified mechanical, electrical and plumbing subcontractors. If a mechanical, electrical and/or plumbing subcontractor listed in any bid or proposal submitted by a general contractor is not prequalified, that general contractor's bid or proposal will not be accepted.
