These UNIT PRICES shall include all charges for labor, materials, fees, layout, supervision (field and office), general expenses, taxes, insurance, overhead, profit, etc., for unit item of work complete in place. The Contract Sum shall be increased or decreased based upon quantity difference multiplied by the applicable unit price. Non-competitive UNIT PRICES for application to Change Orders proposed by the successful bidder may be rejected and competitive prices negotiated by the OWNER prior to contract award.

The BIDDER hereby declares that this proposal is made without connection with any other person, company or parties making a BID or proposal; and that it is in all respects fair and in good faith, without collusion or fraud. The Undersigned agrees that any person, firm or other party to whom it is proposed to award a subcontract under this contract must be acceptable to the OWNER. The Undersigned agrees not to revoke or withdraw this proposal until 60 days following the opening of BIDS. In case the Undersigned is notified in writing by mail or delivery of the acceptance of this proposal within this time, the Undersigned agrees to execute a contract on the prescribed form and based on this PROPOSAL, within 10 days of the notification. The Undersigned agrees further to commence actual physical work on the site with an adequate force and equipment within 10 calendar days of NOTICE TO PROCEED and to prosecute the WORK faithfully with adequate materials and labor to complete same.


