

Answer 1: Note #8 on Estimated Quantities is referring to 3 areas of undercut. Location #1 (Pond- Approximate Sta. 120+00 to 121+50), Location #2 (Unsuitable material – Sta. 129+50 to Sta. 130+50), Location #3 (Unsuitable material – Sta. 158+50 to Sta. 163+58.82)

Question 2: It also states that this is per the Geotechnical report, yet there is no Geotechnical report in any of the documents. Is there a Geotechnical report you can send us?

Answer 2: The geotechnical report has been included an attachment to this addendum.

Question 3: Can an excel sheet with pay items be provided?
