5) What is the projective budget for this project?

6) All the current spindles are basically 7" on center (+/-), are we placing the new cast iron spindles at the same spacing?

Answer: The Spindles should be placed 4" on center.

7) Letter "g" under scope of work states - Replace rail with black cast iron with Trex material with cap (refer to Exhibit #1 on page 4-1.3), are there specific dimensions, currently the existing railings are 2" x 6" pressure treated lumber. I haven't personally seen "Trex" available in those dimensions but will further investigate.

Answer: If not available, 2"X 4" "Trex" rail will be fine.

8) Are the railing posts and side rails to be replaced (entire railing system) or is it only the spindles and cap rails that are to be replaced?

<u>Answer:</u> There might be a few short railing posts that may need to be replaced and all of the spindles and spindle rails.

9) If the entire railing system is to be replaced will a 4x4 post be sufficient and will a wood cap be required for each post.

<u>Answer:</u> The entire railing system, top and bottom is to be replaced. Along with a few of the short post will possibly need to be replaced as well. However, we do want to stay with the 6" X 6".
