This Addendum will respond to questions received and plan clarifications:

Question Set 1: "I have a few questions regarding discrepancies with the bid sheet and plans on this job as listed below."

- Bid Sheet Item #716-13.01 Spray Plastic (4" Line 60 MIL) and #716-13.05 Spray Plastic Pvmt
 Mrkgs According the page C-2 General Notes Final Notes #6 states Item #716-12.01
 Enhanced Plastic (4" Line) be used on the job? We need to know which item number/material is
 correct as there is a significant price difference between Enhanced and Spray Plastic 4" Line.:
 - Response: Note 6 under Final Pavement Marking of Sheet 2C General Notes has been revised to reference item numbers 716-13.02 and 716-13.05 which are included in Estimated Roadway Quantities table on Sheet 2A.

Also, item number 716-13.01 Spray Thermo Pvmt Mrking (60 mil)(4IN Line) has been changed to 716-13.02 Spray Thermo Pvmt Mrking (60 mil)(6IN Line)

- Bid The same C-2 Final Notes #6 States the contractor has the option of using Paint installed to permanent Mrkgs at the end of each day's work and then install the permanent standards after paving is complete etc. I need clarification regarding if we will need to provide the temporary paint is a possibility so we can include the pricing in the permanent markings.:
 - Response: The temporary pavement markings will be paid for under Item Number 716-13.02 Spray Thermo Pvmt Mrking (60 mil)(6IN Line) per L.M. or Item Number 716-13.05 Spray Thermo Pvmt Mrking (60 mil)(6IN Dotted Line) per L.F.

Pay Item Footnote 8 has been added to the Estimated Roadway Quantities table on Sheet 2A and reads: "TEMPORARY PAVEMENT MARKINGS WILL NOT BE PAID FOR DIRECTLY BUT SHALL BE INCLUDED IN THE COST OF OTHER ITEMS"



Plan Clarification Item 1: Notes:

• Standard Lighting notes previously shown on Sheet 2C General Notes have been removed as there are no proposed lighting improvements in this project.

General TDOT/bidding guidance

- No contract license number on outside of bid envelope
- Bind the bid book and be sure all pages are accounted for
- TDOT Identified Common mistakes in bid submittal
 - Failure to sign the bid (proposal form, proposal certification, proposal bond, Power of Attorney)
 - o Failure to furnish the required bid bond and Power of Attorney, with the same dates
 - o Omissions, alterations of form, additions, or conditions not called for
 - Unauthorized bids or irregularities
 - o Failure to include a unit bid price for each item (must be an amount of zero or greater)
 - Unit prices are mathematically unbalanced
 - o Failure to submit a non-collusion affidavit
 - o Failure of bidder to acknowledge all addenda
 - o Bidder not prequalified and not in good standing the day of the letting
- If a new bid form is included in an addendum, the old bid form can be disposed of and the new bid form used in its place.
- All contractors should be aware that they need to be TDOT qualified prior to submitting bids.
