
On the Unit Price Schedule in Exhibit H there is an item listed as "#31 Parking Lot Lighting -1 LS", but there are not any references to any electrical items or lighting on the design plans. Nor is there any spec in the proposal book for this. Please advise whether or not this will be part of the project. If so, please provide design plans to enable us to provide pricing.

#### **Answer 1: Please see attached drawing**

- 1. The parking lot lighting will be a design-build item.
- 2. Please see the attached Parking Lot Illumination Map showing the area to be illuminated.
- 3. The contractor will be responsible for all lighting requirements such as:
  - a. Light pole/fixture installation
    - i. With concrete base as required
    - ii. Light pole/fixtures shall match existing parking lot lighting on site
    - iii. Flood light mounted to building may be utilized for sidewalk lamination
  - b. Underground electrical conduit
  - c. Connection to existing electrical panel inside the building.
    - i. Integration with existing parking lot lighting control (on/off/photocell)
  - d. Meet requirements of the IESNA Lighting Handbook requirements to include (but not limited to):
    - i. Horizontal/Vertical Illuminance
    - ii. Uniformity Criterion
