As a current supplier to this location, we are showing (1) 10,000 gallon Off-Road Diesel Tank and (1) 1,000 gallon On-Road Diesel Tank. Will you please confirm tank sizes or any pending changes?

Response No. 2: Road Department Tank No. 2 gallon size has been corrected (above). All other tank sizes are correct as printed.

Question No. 3: Will there be a separate Bid Request for the Unleaded Tank at Sapillo Creek VFD?

Response No. 3: No, not at this time.

Question No. 4: Can you supply the current usage per month at each of the sites?

Response No. 4: Below you will find a three (3) month average used by the Road Department, as they are the most frequently replenished on an as-needed, regular, monthly basis. The Volunteer Fire Departments replenish fuel on an as-needed, irregular, non-monthly basis; therefore, the County would not be able to accurately provide an average usage for these departments.

Please note that Road Department usage at these locations is contingent upon on-going road projects. Therefore, usage may either increase/decrease on a monthly basis.

Tank 1 (10,000 gal) Average: 7,467 gallons per fill-up (Off-Road)
Tank 2 (1,000 gal) Average: 1,212 gallons per fill-up (On-Road)

Tank (500 gal) Average: 155 gallons per fill-up (Off-Road)
