

RESOLUTION NO. 2019-037

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, TO AWARD THE LOWEST, RESPONSIVE AND RESPONSIBLE BIDDER, RAPID MILLING AND PAVING, LLC, FOR ASPHALT MILLING & RESURFACING SERVICES, ITB 2019-03, IN THE NOT-TO EXCEED AMOUNT OF \$226,493.92; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it is the City of Parkland's (City) intention to engage the services of a qualified, licensed, insured and experienced firm to provide asphalt milling and resurfacing services; and

WHEREAS, on February 14, 2019, in accordance with the City's Procurement Code, City staff advertised, Invitation to Bid (ITB) No. 2019-03 for Asphalt Milling & Resurfacing Services; and

WHEREAS, on March 14, 2019, the City opened the ITB and eight (8) bids were received with no declination; and

WHEREAS, staff has reviewed the lowest bid and after careful evaluation is recommending the award to the lowest, responsive and responsible bidder, Rapid Milling and Paving, LLC, in the not-to-exceed amount of \$226,493.92, and

WHEREAS, staff is requesting the City Commission approve the award to Rapid Milling and Paving, LLC.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA AS FOLLOWS:

Section 1. The foregoing "WHEREAS" clauses are confirmed and ratified as being true and correct and are hereby incorporated herein.

Section 2. Rapid Milling and Paving, LLC is hereby awarded ITB 2019-03 for Asphalt Milling & Resurfacing Services, in the not-to-exceed amount of \$226,493.92.

Section 3. The appropriate City Official is authorized to execute the agreement.

Section 4. The ITB packet has been reviewed and approved by the City Attorney.
