SCOPE

This Addendum forms a part of the Contract and clarifies, corrects, or modifies the original Invitation for Bids document prepared by the City of Avondale. Acknowledge receipt of this Addendum in the space provided on the attached “Acknowledgment of Addenda Received” form. This acknowledgement must accompany the submitted bid. Failure to do so shall subject the bidder to disqualification.

This Addendum No. 1 consists of modifications to Article II (Bid Process; Bid Award), Section 2.15 (Bidder Qualifications), Subsection A (Experience and References) and Exhibit D (References) of the Invitation for Bids No. PW 19-007, released on September 26, 2018.

ADDENDUM

1. Article II (Bid Process; Bid Award), Section 2.15 (Bidder Qualifications), Subsection A (Experience and References) is deleted in its entirety and replaced with the following:
 - A. Experience and Reference(s). Bidder must demonstrate successful completion of at least one similar project (three is preferred) within the past 60 months, which must have a dollar value of at least 75% of the total bid for this Project as set forth in the Price Sheet, attached as Exhibit B. Total bid price does not include any City allowances identified. For the purpose of this Solicitation, “successful completion” means completion of a project within the established schedule and budget and “similar project” resembles this Project in size, nature and scope. Reference(s) for the(se) project(s) shall be listed on the sheet attached hereto as Exhibit D and

incorporated herein by reference. *The reference(s) will be checked*, and it is Bidder's responsibility to ensure that all information is accurate and current. Bidder authorizes the City's representative to verify all information from the(se) reference(s) and releases all those concerned from any liability in connection with the information they provide.

2. Exhibit D (References) is deleted in its entirety and replaced with the References sheet attached hereto as Exhibit 1 and incorporated herein by reference.
