FOR FIRE PROTECTION**

**WHEREAS**, a public notice to bidders asking for sealed bids for "Fire Protection" for additions and renovations to the Franklin County Public Safety Facility was published in the Washington Missourian in the March 30, 2019 edition to submit bids to the Franklin County Purchasing Department by May 9, 2019 at 9:00 AM; and

**WHEREAS**, two (2) bids were received, opened and read on May 9, 2019; and


**WHEREAS**, after due deliberation and consideration by Navigate Building Solutions, FGM Architects, SCI Engineering and the Franklin County Counselor, the Purchasing Department recommends the Franklin County Commission award the bid for Fire Protection for the additions and renovations of the Franklin County Public Safety Facility to the lowest and most responsive bidder, Ozark Fire Sprinkler Company, for the bid amount of Four Hundred Seventy Nine Thousand, Four Hundred and Seventy-Five Dollars(\$479,475.00); and

**WHEREAS**, a copy of the Contract is available to view upon request.


**IT IS THEREFORE ORDERED** that the bid for Fire Protection for the additions and renovations to the Franklin County Public Safety Facility is hereby awarded to Ozark Fire Sprinkler Company for the bid amount of Four Hundred Seventy Nine Thousand, Four Hundred and Seventy-Five Dollars (\$479,475.00) and the Presiding Commissioner is authorized to execute any and all necessary documents on behalf of the County of Franklin and such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Order, for and on behalf of and as the act and deed of the County.

**IT IS FURTHER ORDERED**, that the County shall, and the officials, agents and employees of the County are hereby authorized and directed to, take such further action, and execute and deliver such other documents, certificates and instruments as may be necessary or desirable to carry out and comply with the intent of this Order.
