

RESOLUTION NO. 2020-037

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, TO AWARD THE LOWEST, RESPONSIVE AND RESPONSIBLE BIDDER, SULLIVAN ELECTRIC AND PUMP, INC., FOR THE IRRIGATION PUMP STATION REPLACEMENT AT PINE TRAILS PARK, ITB 2020-08, IN THE AMOUNT OF \$83,839; PROVIDING FOR EXECUTION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Parkland (City) requires the services of a qualified firm to replace the irrigation pump stations at Pine Trails Park; and

WHEREAS, on April 29, 2020, in accordance with the City's Procurement Code, City staff issued Invitation to Bid (ITB) No. 2020-08 for Irrigation Pump Station Replacement at Pine Trails Park; and

WHEREAS, on June 6, 2020, the City opened the ITB and six (6) bids were received; and

WHEREAS, City staff have reviewed the low bid and after careful evaluation is recommending the award to the lowest, responsive and responsible bidder, Sullivan Electric and Pump, Inc., in the amount of \$83,839; and

WHEREAS, funds for Irrigation Pump Station Replacement at Pine Trails Park have been budgeted for the 2020 fiscal year; and

WHEREAS, the City Commission hereby determines it to be in the best interest of the residents of the City of Parkland to award Sullivan Electric and Pump, Inc. for Irrigation Pump Station Replacement at Pine Trails Park.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA AS FOLLOWS:

Section 1. The foregoing "WHEREAS" clauses are confirmed and ratified as being true and correct and are hereby incorporated herein.

Section 2. Sullivan Electric and Pump, Inc. is hereby awarded ITB 2020-08 for Irrigation Pump Station Replacement at Pine Trails Park, in the amount of \$83,839.

Section 3. The appropriate City Official is authorized to execute the agreement.

Section 4. The ITB packet has been reviewed and approved by the City Attorney.


