Notice of Public Meeting

Pursuant to Section 286.011, Florida Statutes, please be advised that a meeting of the Broward County Housing Authority (“BCHA”) Evaluation Committee for RFP 20-283, “General Legal Services” will be held on Thursday, May 7, 2020 from 9:15 a.m. – 1:30 p.m. The BCHA Evaluation Committee will hold this virtual public meeting based on the following findings and procedures:

- On March 20, 2020, Governor DeSantis issued Executive Order 20-69, suspending the requirement that a quorum of the government body be present in person, or that a local government body to meet at a specific public place.
- Consistent with the authority contained in the Governor’s Executive Orders, and in order to ensure the health, safety, and welfare of the BCHA’s clients and employees, the BCHA finds that it is in the best interest of the BCHA to hold this virtual public meeting.
- Therefore, the BCHA will be holding this virtual meeting through the use of the following Communications Media Technology: Zoom.

The purpose of this meeting is for the BCHA Evaluation Committee to interview the respondents who are shortlisted and discuss the final ranking on the shortlisted respondents for the recommendation of Award to the Board of Commissioners for solicitation RFP 20-283, “General Legal Services.” The meeting will be divided in two portions. One portion will be open to the public, and the other portion, during which the Evaluation Committee will conduct interviews, will be a shade session and closed to the public.

The shade session portion of the public meeting will not be open to the public pursuant to Section 286.0113(2)(b)1, Florida Statutes. The shade session portion of the meeting will be attended by, Teisha Palmer, Acting Procurement Manager; the BCHA Evaluation

Committee members; and the respondents. It is anticipated that the shade session portion of the public meeting will be held from 9:45 a.m. – 11:30 a.m.

In accordance with Section 286.011, Florida Statutes, the portion of the evaluation committee meeting that will be open to the public will be held via Zoom on **May 7, 2020** from **9:15 a.m. - 9:30 a.m., and then following the interview shade session from 11:45a.m. – 1:30 p.m.** Please be aware the Evaluation Committee meeting is a public meeting, and not a public hearing.
