RFQ 20-18-003 – Full Body Scanning System dated May 4, 2020 is hereby amended as noted herein: BIDDER TO ACKNOWLEDGE RECEIPT OF ADDENDUM BY SIGNING ON THE SIGNATURE LINE BELOW AND INCLUDING A COPY WITH SUBMITTED BID. FAILURE TO DO SO MAY, AT THE OWNER'S DISCRETION, SUBJECT THE BIDDER TO DISQUALIFICATION

- 1) QUESTION: One of the requirements is to send a "COPY OF THE BUSINESS LICENSE and COPY OF ANY PROFESSIONAL LICENSURE ASSOCIATED WITH THE WORK TO BE PERFORMED." Our company is located in FL and we do not have this since it is not required for our work. Will we still be able to participate if we do not send these licenses?
  - <u>ANSWER:</u> The business would only be required to produce whatever licenses that they are required to have unless the RFQ requires the business to have a certain type of license; if the County RFQ doesn't require a certain license, I would say that they can still participate.
- 2) <u>QUESTION:</u> I noticed a due date discrepancy for the above referenced bid on two different bid sites. The sites both state that this RFQ is due June 12<sup>th</sup>, but the document states the 10<sup>th</sup>. We are planning to submit by the 10<sup>th</sup>, but just wanted to make you aware of the discrepancy.
  - ANSWER: Bids are due Wednesday, June 10<sup>th</sup> by 11:00am. I apologize for this discrepancy.
- 3) <u>QUESTION:</u> We do not use subcontractors and all of our installation technicians that will be on the project if successful will be U.S citizens. Due to that factor, do we to still utilize the E-Verify system?
  - <u>ANSWER:</u> Attachment E will still be required. I believe businesses with 10 or more employees are required to participate in E-Verify. If you do not participate in E-verify, just notate that on the form.
- 4) <u>QUESTION</u>: Do you happen to know the dimension of the proposed area, to include width, length, and height?
  - <u>ANSWER:</u> A layout is included later in the Addendum. The room is 10 ft x 7 ft and a ceiling height of 8 ft. The body scanner will need to fit in this space and still allow for personnel for maneuver around the machine.

5) QUESTION: 3. One of the technical specifications is as follows: *System should be a 360-degree open frame design where line of site is not compromised.* Our system is a tunnel system but has no Exclusion Zone, meaning that the Operators Station can be directly beside the scanner system, and also has a camera that is used during the scanning process.

ANSWER: This setup would meet our needs.

6) <u>QUESTION:</u> Could you please provide the measurements of the area that the whole body scanner must be installed in.

ANSWER: This information will be added after the questions.

- 7) QUESTION: What is the ceiling height of the installation area? ANSWER: 8 foot ceiling.
- 8) QUESTION: Is it desired to have the Operator Workstation mobile or stationary? ANSWER: Either is fine.
- 9) <u>QUESTION:</u> Where is the desired location of the Operator during the scanning process compared to the scanner itself? <u>ANSWER:</u> Adjacent to the machine.
- 10) <u>QUESTION:</u> Please confirm the dimensions allocated to the Body Scanner (including the required radiation safety/operating space). Would it be possible to receive a drawing/photo of the proposed location to allow us to include an Install Lay-out with our Bid Submission?

ANSWER: This information will be added after the questions.

- 11) QUESTION: Please confirm if the contraband sought to be detected by the Body Scanner includes narcotics that may be hidden within body cavities?
  ANSWER: Yes.
- 12) **QUESTION:** Please confirm if remote diagnostic support is required for the Body Scanner?


ANSWER: Not required.

13) **QUESTION:** Please confirm if the Body Scanner is to be integrated with the Agency's Jail Management System?


ANSWER: Not required.
