2. Answers to written questions:

Q1. Can you please provide the previous bid tabs?

**A1. See attached**

Q2. Is this a designated MWBE bid? The last paragraph on page 1 states "Contractors submitting bids to the City must comply with Article III of Chapter 30 of the Code of the City of Daytona Beach, Florida, "Minority and Women Owned Business Enterprises."

**A2. You do not have to be a minority business as defined under Chapter 30 to bid on this project. We keep track of those businesses which are awarded contracts.**

Q3. What is the actual size of the bleach tank?

**A3. 175 gallon chlorine tank, 100 gallon acid tank**

Q4. Is it mandatory to make a weekly delivery if the tank isn't at the 1/4 minimum level listed in the bid?

**A4. No. It is acceptable to use technology to monitor tank levels off site and fill as needed as long as the successful company assures not running out.**

Q5. What is the anticipated start date of the contract?

**A5: April 18, 2019 or the date the City Commission approves the contract, whichever is later.**

3. All other terms and conditions remain the same.
