#### **PURPOSE**

This Addendum forms a part of the Contract and clarifies, corrects, or modifies the original Invitation for Bids document prepared by the City of Avondale. Acknowledge receipt of this Addendum in the space provided on the attached "Acknowledgment of Addenda Received" form; this acknowledgement must accompany the submitted bid. Failure to do so may subject the bidder to disqualification.

This Addendum No. 1 consists of one (1) modification of following:

Modification 1.	1.2.2.1. Daily pProject monitoring.
Modification 2.	1.6. <u>Project Proposal and Cost Estimate</u> : Before commencing each project, the Consultant shall prepare a proposal with an estimated number of hours needed and a not to exceed price or a lump sum price
Modification 3.	2.5.2. Project Approach (maximum 40-60 points)
Modification 4.	2.5.3. Price Proposal (maximum 20 points)
	The lowest responsive price proposal shall receive the full 20 points. The next lowest responsive price proposal shall receive a portion of the full 20 points equivalent to the percentage between the lowest and next lowest price proposal (i.e., if Proposal X submits the lowest responsive price proposal of \$80 and Proposal Y submits the next lowest responsive price proposal of \$100, Proposal X receives 20 points and Proposal Y receives 20 points and Proposal Y receives 20 points x (\$80/\$100) or 16 points).

Modification 5.	2.6. The City will enter into negotiations with the highest ranking Firm for each phase. If the City is unsuccessful in negotiating an Agreement with the highest-ranked Firm, the City may then negotiate with the second, then third, highest-ranked Firm until an Agreement is executed. The City reserves the right to terminate the selection process at any time. Award will be made to the Consultant whose proposal is the most advantageous to the City.
