**Pool Timing System**

The purpose of this Addendum #01 to IFB 19-B0003 for Pool Timing System, dated July 13, 2018, is to answer the following questions:

1. Are line 1 and line 2 on the price schedule meant to be identical?

No, line 1 and line 2 on the price schedule are not meant to be identical. Please use the revised price schedule that is attached to this addendum which shows the correct item/description on line 2.

2. Line 3 is titled as being a scoreboard adapter, but the description sounds like it is the scoreboard itself. Is the intent for it be a scoreboard with the wireless adapter?

No, the intent of line 3 on the price schedule is to be the adapter only, not the scoreboard. The adapter is just a small box that plugs into the scoreboard that allows the scoreboard to receive a signal from the Dolphin system.
