The following are amendments to the IFB #340-19 On-Call Full Depth Reclamation Services:

1. The Vendor's Price Proposal form has been revised and attached to this IFB. Please submit in lieu of the form included within the IFB document.
2. All dates, other specifications, terms and conditions remain the same as posted in the RFP document.

The following are questions and answers to the IFB #340-19 On-Call Full Depth Reclamation Services:

QUESTION: The bid is labeled an 'on demand FDR services' bid. However, three specific roads are listed. Is the scope to include only these three roads? Or these three roads plus additional roads to be determined at a later date?

ANSWER: As stated on page 10 of the IFB document, the roads included are samples of projects that the County anticipates. Also stated on page 10, is direction to list pricing on the Vendor's Price Proposal form for this project to allow for equal comparison for all responses received. As stated on page 11 of the IFB document, the Contractor shall complete an estimate for each project to be approved by the Dawson County Public Works Director before any work begins. This process will be followed for future needs of the County.

QUESTION: What is included in the 5 year warranty? Also a corollary question, who is responsible for the testing? If all the testing (compaction testing, core breaks, etc.) pass during the construction, what is there to warranty?

ANSWER: The 5 year warranty is for the full depth reclamation work only. Testing is the responsibility of the Contractor as stated on page 11 of the IFB document. The warranty will apply to the full depth reclamation base.

QUESTION: Page 37 – bid form. There are five items listed, two have quantities. Is the bidder supposed to enter quantities on the other items?

ANSWER: A revised Vendor's Price Proposal is attached. Please submit this in lieu of the form included in the IFB document.

QUESTION: What is the timeframe for completing the work?

ANSWER: Each future project's timeframe for completion will be determined upon receiving the estimate and agreed upon by both parties. The timeframe for the sample project will be set at the pre-construction meeting and placed in writing on the Notice to Proceed Date letter.
