FAILURE TO DO SO MAY, AT THE OWNER’S DISCRETION, SUBJECT THE BIDDER TO DISQUALIFICATION

- 1) QUESTION: You stated that you need this system work wirelessly, we can achieve this in two ways: using your Wi Fi or using satellite - Which system you prefer? Please be aware if you want satellite then a monthly or annual fee will occur for using the cloud, and if you want to use Wi Fi then you need to provide a reliable Wi Fi to get reliable system.
ANSWER: We will move forward with Wi-Fi, and this will be handled by our IT department.
- 2) QUESTION: Tank monitor that you guys have does not have the capability to communicate with the new fuel management system nor the wireless compatibility. I know that you said that the budget is tight, but should we offer you a new system that fit your application and need
ANSWER: We will update the bid form to add an alternate for a new tank monitoring system. See Attachment A.
- 3) QUESTION: How many cars should be in the system to fill up gas or diesel? I know you guys said it could be up to 400 vehicles down the road, but I want to know as of today, how many?
ANSWER: 309 units will be entered immediately upon installation of the system however system must be capable of handling up to 500 units.
- 4) QUESTION: Do you need to do anything with the transactions that are collected by the fuel pedestals? Do they need to be imported into any other systems for reconciliation or billing?
ANSWER: No direct importing is needed. Transaction reports must be downloadable in PDF and CSV format
