Scope of work to be:

New single-story, slab on grade, CMU walls and wood roof truss framed restroom building consisting of 370 SF interior space and 426 SF under roof.

Major systems include:

- Structural: Concrete footings and floor slab, CMU block walls, wood trusses, and roof deck.
- Architectural: Hollow metal doors and frames, Painted CMU block partitions, moisture resistant gypsum ceiling, toilet accessories, and shingle roofing.
- Electrical: Lighting and power
- HVAC: instantaneous water heater, exhaust duct, and roof vents
- Plumbing: Wall mounted lavatories and water closets, drinking fountain, copper water supply, and sanitary sewer piping.
