Addendum #02 March 8, 2022

IFB 22-B0030 City Wide Pavement Marking Project

The purpose of this Addendum #01 to IFB 22-B0030 for City Wide Pavement Marking Project, dated February 2022 and previously amended on March 3, 2022, is to answer the following questions:

1. Will a line item be included for the removal of existing markings?

Yes, line items have been added to the new bid schedule, which is attached and is hereby included as part of this addendum. Please note that on the bid tab for Market Common, line item #26 includes parking stripes. The linear footage is the exact thermo length, and not the road length. On the bid tab for Citywide Pavement Marking, measurements are road length.

2. Can you provide us with the City's pavement marking standard drawings?

Please refer to SCDOT Section 627 and any additional supplemental specifications to this section.

In addition, the project description is revised to the following:

To replace and remark various types of roadway pavement markings on roads and intersections throughout the City. Pavement markings to be installed in the same locations, sizes and dimensions of existing markings being replaced. All pavement markings to be thermoplastic, unless otherwise specified, in accordance with City Specifications 321724 and all applicable MUTCD (Manual of Uniform Traffic Control Devices) standards and guidelines.

The contractor shall provide all supplies, personnel, equipment, tools, materials, supervision and other items or services necessary to provide for the replacement of striping and markings on specified roadways and intersections.

The contractor shall be responsible for providing appropriate temporary traffic control in work zones which may include but not be limited to work zone signage, traffic cones, flagmen, detours (if applicable), and/or other devices used to guide road uses. All traffic control devices shall conform to MUTCD provisions.

The contractor shall field check and verify existing conditions prior to work and notify the City's Representative of any discrepancies, conflicts and/or installation concerns immediately upon discovery. The City reserves the right to add or delete roads as necessary.

Sealed bids are no later than Thursday, March 10, 2022 at 2:00PM (local time.) No electronic bids will be accepted. The City is not responsible for late or misdirected mail.
