Q1. Item #3-This item has been discontinued by Akron Brass Co. Is there an alternate you would accept?

A1. #3 - Oconee County will accept any brand but it needs to be in 51" range.

**Q2.** Item #20 - Requesting LED light, but asks for 750 watts. LED lights usually come in LUMENS. Is the Telelite product with 15000 lumen LED acceptable?

A2. #20 - Yes, please replace 705 watts with 15,000 lumens.

**Q3.** Item #22 - Please confirm part#. SPA700 does not appear to be correct. Do you need SPAKR700-K20-ON, which is the LED with the 3-legged portable base? If not the portable base, are you looking for the 3-legged tripod? Tripod comes in full, medium or small...Please advise if one of these is desired.

A3. #22 - SPAKR700-K20 is acceptable, but appears on website as same as FRC SPA700-K20.

**Q4.** Item #3, Akron does not make the PPB-51 anymore, could Fire Hooks CBPP-51 or Council Tools 120PP be an alternative?

## A4. Yes, both alternatives are acceptable. Item needs to be in the 51" range.

**Q5.** Items #9 and #10 (at the end of bid document under Exhibit A, description says straight handle on left and D-handle on right, which one is preferred?

## A5. The correct specification is "Straight Handle".
