KCDC is using this addendum to answer the questions raised about this solicitation. To aid in readability, the questions are in black, the answers are in bold, and the answers follow immediately below.

Does KCDC want the new flooring under the dishwashers?		
No. Adjust paragraph 3i according by removing the word "dishwasher."		
Will KCDC accept alternate flooring materials?		
No. KCDC wants the flooring to match that installed earlier this year. Thus, only Metropolitan		
Luxury Vinyl Plank Style DVN13 12mil in the color 768 Bridgeway is acceptable. This changes		
paragraph 2.		
Will KCDC inspect the work?		
Yes. Once the vendor finishes a building, KCDC will inspect the work quality before allowing the		
vendor to proceed with other apartments.		
The manager said that the 87 units quoted will actually be less since apartments that become vacant		
must be made ready for occupancy as soon as possible. How do we account for the price difference?		
KCDC has revised the pricing sheet to provide not only a grand total cost, but price per apartment-		
based upon apartment size. See the revised sheet on page two.		
Is KCDC going to provide a list of the apartment numbers to be serviced?
