**Question 1.** Are as-built drawings showing the existing conditions available? **Answer:** See attached As-built drawings.

**Question 2.** Can a site plan be provided showing any access roads, structures, ponds, etc. surrounding the work area?

Answer: See attached "Exist. Site Plan" exhibit.

**Question 3.** Please provide elevation for new 24" base 90 degree elbow inside of Surge/Aeration Tanks 1 and 2.

**Answer:** The elevation is left to the Contractor for convenience of installation of influent pipes; 7 ft. is the maximum height for the pedestal off tank floor as shown on plans.

**Question 4.** Please advise who is responsible for pumping out Surge/Aeration Basins for installation of piping and base 90 concrete supports.

**Answer:** The Contractor is responsible; County will allow trucking to the Gifford plant (3550 49<sup>th</sup> Street).

**Question 5.** Please advise if the Surge/Aeration Basins are required to be cleaned while they are out of service. If so, please advise who is responsible for cleaning.

**Answer:** The Contractor will be responsible for pump-out of the surge/aeration basins and removal of bottom sludge build-up cleaning only the area needed to install the base elbow support.

**Question 6.** The bid form (Bid item 5) states to reference section 1.03 for max amount. However, I do not see this section in the specs. Is there a max amount for this bid item on this project?

Answer: No Max Amount. Bid Form has been revised.

### **Additional Clarifications**

- 1) A bid item (8) has been added to account for the probability of sheeting and/or bracing of approximately 20 LF ± of the existing 8" retaining wall north and center of the pipe excavation located in the center area of the north surge tank walls (see plans for exact location).




