The purpose of this Addendum 01 to IFB 23-B0047 for Murray Avenue and Kruzell Street Streetscape Improvements, dated April 6, 2023, is to list the key points of discussion from the mandatory pre-bid meeting and provide the sign-in sheet that is attached and is hereby made a part of this addendum.

- This is a 60 day project. Liquidated damages are \$500.00 per day.
- During work, irrigation laterals must be capped and labeled.
- Some sections of concrete sidewalk will need to be removed and replaced. The City will mark the sections for replacement.
- All new trees must be inspected by the City and/or Engineers prior to planting.
- The Contractor will be responsible for re-stripping new asphalt.
- Work may be performed on any day, during daylight hours.
- Traffic control may consist of cones and signage. If there are any safety hazards, the hazardous areas must be clearly blocked off.
