The purpose of this Addendum 01 to IFB 23-B0046 for New Kitchen Equipment for the Myrtle Beach Convention Center, dated March 8, 2023, is to list the key points of discussion from the mandatory site visit.

- Zeke Fowler and the Chef will coordinate with the Contractor to have a day after the old equipment is removed so the Convention Center staff can clean behind where the new equipment will be placed.
- The Contractor will be responsible for removing and disposing of the old equipment that is being replaced.
- Contractor will be responsible for installing any hook ups to make the new equipment work.
- The City will be responsible for inspections and permit fees. Contractor will be responsible for all other licenses and fees, including a City business license.
- Any contractor who desires a second visit to inspect the work area prior to submitting a bid must make an appointment with Zeke Fowler by calling 843-918-1258.
