### **Questions:**

1. Please clarify Note 1 on each of the drawings which states “Drainage Pipe And Structures Not Constructed Per Plans. Contractor To Verify”. What is the Contractor to verify?
  - The drawings are not asbuilts. However, the distances between manholes have been verified on the bid schedule. There may be some variation between the plans and the existing conditions (elevations, etc).
2. Given Bid Item 5 Bypass Pumping & Traffic Control, please confirm we must allow home owners complete access to their property. Please also confirm traffic control must be in conformance with SCDOT and MUTCD standards.
  - Confirmed.
3. How many lineal feet of pipe can we isolate at one time to perform all the work described in the bid documents?
  - The means and methods of the work are at the discretion of the contractor. However, flow and traffic must be maintained.
