WHEREAS, a Public Notice to Bidders asking for sealed bids for Culvert Materials; Bituminous Plant Mix Materials; Sign Materials; Bituminous Materials; Concrete Materials; Aggregate Materials; Equipment Rental; and Propane was published in the Washington Missourian October 20, 2021 edition for receipt by November 16, 2021; and

WHEREAS, a Public Notice to Bidders asking for sealed bids for Fuel; Lubricants; Cutting Blades; Pavement Marking; Tires; Heavy Duty Equipment; and Auto Fleet Maintenance and Repair was published in the Washington Missourian October 27, 2021 edition for receipt by November 18, 2021; and

WHEREAS, due to the ever fluctuating needs of the Highway Department for contractual services it is necessary that several options are always available in the event that one or more service providers are unable to provide the necessary services at the desired time; and




