

RESOLUTION NO. 2020-022

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, TO AWARD THE LOWEST, RESPONSIVE AND RESPONSIBLE BIDDER, SANTANA PRESSURE CLEANING SERVICES, INC., FOR CITYWIDE PRESSURE CLEANING SERVICES, ITB 2020-01, IN THE ANNUAL AMOUNT OF \$46,276, FOR A POTENTIAL FIVE-YEAR AMOUNT OF \$231,380; PROVIDING FOR EXECUTION BY THE APPROPRIATE CITY OFFICIAL; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it is the City of Parkland's (City) intention to engage the services of a qualified, licensed, insured and experienced firm to provide citywide pressure cleaning services; and

WHEREAS, on February 10, 2020, in accordance with the City's Procurement Code, City Staff advertised, Invitation to Bid (ITB) No. 2020-01 for Citywide Pressure Cleaning Services; and

WHEREAS, on May 5, 2020, the City opened the ITB and eleven (11) bids were received; and

WHEREAS, City staff has reviewed the low bid and after careful evaluation is recommending award to the lowest, responsive and responsible bidder, Santana Pressure Cleaning Services, Inc., in the annual amount of \$46,276, including \$41,276 for the various locations identified in the ITB, and \$5,000 for optional locations as needed; and

WHEREAS, the contract term is for an initial two-year period with three, one-year renewal options, for a potential five-year amount of \$231,380, if determined to be in the City's best interest and funding approved in the applicable fiscal year budget by the City Commission; and

WHEREAS, City staff is requesting the City Commission to approve the award to Santana Pressure Cleaning Services, Inc.; and

WHEREAS, funds for citywide pressure cleaning services have been budgeted for the 2020 fiscal year; and

WHEREAS, the City Commission hereby determines it to be in the best interest of the residents of the City of Parkland to award Santana Pressure Cleaning Services, Inc. for citywide pressure cleaning services.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA AS FOLLOWS:

Section 1. The foregoing "WHEREAS" clauses are confirmed and ratified as being true

and correct and are hereby incorporated herein.


Section 2. Santana Pressure Cleaning Services, Inc. is hereby awarded ITB 2020-01 for Citywide Pressure Cleaning Services, in the annual amount of \$46,276, including \$41,276 for the locations already identified in the ITB, and an additional \$5,000 for optional services as needed.

Section 3. The appropriate City Official is authorized to execute the agreement.


Section 4. The ITB packet has been reviewed and approved by the City Attorney.
