#### The following update is made to the Technical Specifications:

Modify second bullet as follows:

• Bidders must include a summary of any specific conditions required for the construction as part of their bid package (<a href="Item1">Item 1</a> on the first page of the bid form Affidavit of Compliance Form).

**Contractor** will be responsible for safely removing the portions of the white fencing to facilitate construction of the fruit stand. County will provide storage for the fencing in the garage on property. **Contractor** will be responsible for reinstalling the fence after completion of construction. The final location of the north-south portion of the fence will be determined by the County and Contractor. At completion, the fence must provide security for the homestead site in the same manner it does now.

Indian River County will provide all construction staking and as built services for the completion of the project. No survey services are needed. The bid form has been updated and is attached.

The patio table located in the fenced area will be moved away from the construction area by County staff.
