



COMMISSION ORDER

Tuesday, August 17, 2021 Contract/Agreements

IN THE MATTER OF APPROVING AND AUTHORIZING **EXECUTION OF THE EMERGENCY PROCUREMENT OF** NOVASTOR DATACENTER FROM NOVASTOR

WHEREAS, Franklin County currently utilizes 10TB of NovaStor backup storage software ("NovaStor DataCenter") for the Franklin County Government Center, Judicial Center, Health Department and Historical Courthouse; and

WHEREAS, NovaStor DataCenter ensures Franklin County's electronic data storage is properly protected; and

WHEREAS, due to the additions and renovation to existing Franklin County Sheriff Station, Jail and Communication Center it is necessary to increase Franklin County's front end data limit to 25TB; and

WHEREAS, pursuant to §3-106 of the Franklin County Purchasing Policy Manual, by direction of the County Commission, the Purchasing Agent may make or authorize others to make emergency procurements of supplies, services, or construction items when there exists a threat to public health, welfare, or safety; provided that such emergency procurements shall be made with such competition as is practicable under the circumstances; and

WHEREAS, to ensure Franklin County's electronic data storage is property protected the Franklin County Commission hereby finds and determines it is in the best interest of Franklin County to approve the emergency procurement of the 25TB of Novastore DataCenter from NovaStor for the total annual cost of \$11,812.50 and an additional front end data rate/TB not to exceed \$450.00 as shown in the NovaStor License Agreement attached hereto and incorporated by reference herein.

IT IS THEREFORE ORDERED by the Franklin County Commission that the NovaStore License Agreement with NovaStor is hereby accepted and approved and that Shakara Bray, Purchasing Director, is hereby authorized to execute any and all necessary documents to carry out and comply with the intent of this Order.

IT IS FURTHER ORDERED that a copy of this Order and the executed Agreement be provided to NovaStor; Dave Hagedorn, AQM; Ted Wuertz, AQM; Ray Barry, AQM; Sheriff Steve Pelton; Shakara Bray, Purchasing Director; Lynne Maloney, Accounts Payable; and to Angela Gibson, Auditor.

- 3. Exceeding Data Limits: If Front End Data Limit exceeds the allotted amount, the Recurring License Fee will be adjusted and rounded up automatically to the nearest TB at the Additional Front End Data Rate listed above.
- 4. Cancellation: To cancel this Agreement, Licensee must provide NovaStor with a minimum 5 business days notice prior to the end of the Recurring License Term. There are no refunds for early cancellations.
- 5. NovaStor has the right to terminate this License Agreement and the Licensee's use of the NovaStor Product in the event of non-payment of Recurring License Fee after a 15 day grace period.
