(1) The following clarifications are issued in response to questions submitted:

A. Blue jeans can be a part of the uniform.

B. The original specifications required the Contractor's employees to have "appropriate credentials" from health authorities. We have determined that such credentials are not available. This requirement is deleted from the specifications.

C. The use of styrofoam cups for drinks is acceptable.

D. Exclusivity: concessionaire shall have first right of refusal for any food or beverages sold or distributed on our property. We already have signage posted that coolers are not allowed, but this will prohibit outside vendors and companies from selling and competing with what the concessionaire is serving.

E. The City will require a lump sum payment as well as a percentage of total sales at the end of the calendar year. In evaluating the Proposals, both will be considered - 75% weight for the lump sum and 25% for the percentage of total sales.
