- A. The purpose of this addendum is to provide clarification to vendor questions:
  - 1. **Question:** Can a bid extension of additional 14 days be considered due to receiving pricing for the communications portion of this project?

Answer: Yes, see addendum #1 extension to Wednesday, December 6, 2023, at 2:00PM.

2. **Question:** Would you like the contractor to bid based on the sizes of gates as listed or by the note on the plans that states gates to be 4' wider than the road?

**Answer:** Follow the plan notes, 4' wider than the road.

- 3. **Question:** Clarification, Note that the scale is wrong on the Site Plan. Site fencing approximates roughly 3422', not 985'. What is correct?
  - **Answer:** The scale is correct on the site plan. The site fencing does approximate to close to the 3,422', but prospective bidders shall perform their due diligence and verify the total linear footage of the fence.
- 4. **Question:** The maximum width size for a LiftMaster Operator on a swing gate is 22'. Can specs be modified to use 2- roll gates for the bus entrance?
  - **Answer:** We need (2) 12'-0" swing gates 110-degree swing. The LiftMaster operator shall be revised to model HDSW24UL, which has capacity for the larger swing gates.
- 5. **Question:** Are the exit gates getting hardwired keypads and passport receivers? The plans state 'every' gate or should free exits be used?

**Answer:** Exit gates should be free exit only.

6. **Question:** Does the bus entry and exit need to open 180 degrees? Clarification, any gate operator that opens 180 degrees will only work for a 13' gate. If yes, to 180 degrees opening on the bus entry and exit, can the gate be changed to a slide/roll gate?

Answer: The (2) bus entry gates shall open to 150 degrees.

- 7. **Question:** For the Telephone Entry Unit AKA AI Phone, cannot find anything with 4- programmable relays that uses a modem. Are 4- relays in the AI phone needed or can 2 relays, or add expansion boards to get the extra ones?
  - **Answer:** Add expansion boards as needed to make up the (4) relays needed.
- 8. **Question:** Specs call for both slats and windscreen for the dumpster enclosure gates, Please provide clarification for slats or windscreen?

**Answer:** Provide windscreen enclosure gates, color to match the chain-link fence fabric color.

9. **Question:** It is not recommended to use slats or windscreen on the larger gates as this creates too much wind resistance and can interfere with closing. Can specs be modified?

**Answer:** Provided windscreen where specified in the construction documents.



10. Question: Can specs be modified to use decorative aluminum instead of steel for the dumpster enclosure?Answer: No, please provide black vinyl coated chain-link fencing as indicated in the contract documents.
