TO ALL SUPPLIERS: This addendum is being issued for the purposes of modifying the original Solicitation, through addition, deletion, clarification or correction as outlined herein. The information provided in this addendum supersedes any information previously provided in the referenced document(s). This addendum and the information contained herein shall be used in the preparation of any response submitted by the Supplier and shall become an integral part of the contract documents for any contract awarded for the project specified. Please inform all concerned that the Solicitation is modified by this Addendum.

**QUESTIONS:**

- Q1.** Will the contractor be required to mill and or pave into side roads?  
**A1.** No. Only mill to the edge of the road being paved.
- Q2.** I did not see any attached map. Where do I find the location?  
**A2.** The map of the paving area was added with the first Addendum; it shows the start and stop points on Experiment Street.
- Q3.** What will be the required cover up time on milled surfaces?  
**A3.** 15 business days excluding weather delays.
- Q4.** Will the 9.5mm be Type 1 or Type 2?  
**A4.** Type 1.
- Q5.** It looks like the existing asphalt has been placed in the gutter of the rollback curb. Will the new paving be placed back in the gutter?  
**A5.** No. Gutter should be milled to remove existing asphalt and remain free of asphalt when resurfaced.
- Q6.** Can the location of the 15,00 square yards of Milling at 2" – 4" be identified?  
**A6.** There is no specific location that is currently known. This pay item is in place in case milling is required at depths greater than 2".
- Q7.** Will the Leveling be as needed or is there a location that the Leveling will be used?  
**A7.** Leveling will be as needed.
- Q8.** Since Experiment St. parallels the railroad tracks will the contractor be required to supply any Railroad Insurance and or Railroad Flagging for this project?  
**A8.** No.
- Q9.** There is a little area of side parking that is between N.13<sup>th</sup> St. and N.14<sup>th</sup> St.. Will this area be milled and paved?  
**A9.** If quantities allow this to be resurfaced, we will resurface. No milling will be done. .

**Q10.** Items #20 & #21 Adjustments. Please clarify what you are asking the contractor to give a Unit Price for. Adjustments for manholes & water valves?

A10. Those are included to basically identify any needed work that is not already listed. It is possible that those rows will not be used.

**Q14.** How many adjustments will be needed?

A14. Your site visit will give you the most information. There may be adjustments need that are not readily visible. We are not aware of any adjustments already identified.
