As a result of inquiries, the following clarifications/changes are provided for your information. Please make all appropriate changes to your bid documents. Note: changes are reflected with original language shown with strike-through and new language is underlined.

- Q1. Can selected projects showing team experience be from prime or sub firms?
- A1: Similar projects must be completed by the Respondent (or a combination of the firm, individual, or project manager assigned to the work) and the Respondent's Key Personnel must have the required experience.
- Q2: This only needs to be uploaded via demand star, and no hard submittal needs to be delivered?
- A2: If the proposal is uploaded to Demandstar, no other submittal is needed. The Proposer also has the option to submit a jump drive in a sealed envelope to the Palm Bay Service Center, but both are not needed. No hard copies are needed.
- Q3: Will 11x17 pages be acceptable for Org Chart and visuals?
- A3: Yes
- Q4: For tab 2, should the included resumes be in SF 330 format?
- A4: The SF 330 format is not required.
- Q5: For the tabs/sections that do not have a form associated, will there be a page count limit? A5: No
- Q6: Is a graphic cover page allowed?
- A6: Yes
- Q7: Are subconsultants allowed to be on more than one team?
- A7: Yes
- Q8: Should subconsultant resumes be included under Tab 2 as well?
- A8: If subconsultants are key personnel, then include their technical qualifications and experience in Tab 2.
- Q9: What is the construction funding source for this project? State/federal?
- A9: There are multiple different projects that may be funded under the General Engineering Services contract. Funding sources for each project may vary and could potentially include State or Federal funds.

- Q10: Is grant funding being sought?
- A10: Grant funds could be sought for various projects.
- Q11: Are there any previous reports/studies available for review?
- A11: Various plans and reports on our website <u>www.sjrwmd.com</u>.
- Q12: Is Geotechnical evaluation, Survey work, and Environmental assessment required under the new scope of work described in Addendum 1?
- A12: Geotechnical evaluation, Survey work, and Environmental assessment may be ancillary elements to the conceptual, preliminary, and engineering design and feasibility services that is being requested.
- Q13: Is Geotechnical evaluation, Survey work, and Environmental assessment preferred?
- A13: See response in A12 above.
