This addendum will amend **Bid #22-005, Maintenance of Athletic Fields, IDIQ** originally issued on Thursday, September 29, 2022. This clarification is being provided to all known and registered correspondents in response to questions received. Question 1: It is referenced in the Contractual Activities Section #5 that successful bidder is required to be a Certified Field Builder. After reading the scope of work, I did not see any “construction” in the bid proposal. I was wondering if this was an error and meant to say required Certified Sports Turf Manager? Due to the fact that the bid is for “maintenance” it raised a concern, and I thought I would ask the question.

Answer: **No, it was not an error. The department listed this requirement versus the Certified Sports Turf Manager as the requirements are more stringent for a Certified Field Builder. However, we do not want to limit competition, therefore, the County will consider a Certified Sports Manager as well. Please list any applicable certifications in your submitted bid. The bid specifications shall be changed to read as follows.**

From:

“5) Successful contractor must be a Certified Field Builder recognized by America’s Sports Builders Association (ASBA).”

To:

“5) A Certified Field Builder (CFB) recognized by America’s Sports Builders Association (ASBA) or a Certified Sports Field Manager (CSFM) recognized by the Sports Turf Managers Association (STMA) is highly preferred.”
