- 1. What will be the allowed work hours on this project?
  - a. Anytime during daylight hours.
- 2. Will the Stop Bars be thermoplastic or paint?
  - a. Thermoplastic.
- Will the contractor be required to install post mounted Advanced Warning Signs or can tripod signs be used?
  a. Tripod signs are allowed.
- 4. What type asphalt mix will be used for the Leveling?
  - a. 9.5mm
- 5. Will an MTV (Shuttle Buggy) be required on placing the 12.5mm on this project? a. No.
- 6. Will the contractor be required to pave into driveways or can the spreader gate be run out at each driveway?a. Spreader gate will be allowed to run out. There may be areas that additional mix will have to be used.
- 7. Will the contractor be required to pave to the back of the radius on side roads or can the spreader gate be run out at each side road?
  - a. Most side roads will be required to be paved back to the radius. There may be some that will not require that.



- Can the roads that are 14'-16' wide be paved in (1) pull instead of two?
  a. Yes.
- It looks like the County will perform any needed shoulder building and grassing correct?
  a. Correct.
- 10. Will the contractor be required to perform any milling on this project?

a. No.11. Will the contractor be required to perform any patching on this project?

- a. No.
- 12. It looks like the contractor will be required to install the Low/Soft Shoulder Signs and the County will retain after the project has been accepted correct?

a. Correct.

I also hereby agree that Lumpkin County would suffer damages in a sum equal to at least the amount of the enclosed Bid Guaranty, in the event my Bid should be accepted and a Contract tendered me there under and I should refuse to execute same and furnish bond as herein required, in consideration of which I hereby agree that, in the event of such failure on my part to execute said Contract and furnish bond within fifteen (15) days after the date of the letter transmitting the Contract to me, the amount of said Bid Guaranty shall be and is hereby, forfeited to Lumpkin County, as liquidated damages as the result of such failure on my part.

I further agree to execute a Contract prepared by Lumpkin County as soon as the work is awarded to me, and to begin and complete the work within the time limit provided. I also propose to furnish the Bonds as required by the Bid Documents and laws of the State of Georgia.
