- 1. Is it within the procurement rules for any respondent to directly contact the current private operator, Motivate, to discuss potential transition plans and other programmatic factors in order to provide a solid response to the RFP?
- 2. Who currently hosts the Bike Chattanooga website? If Motivate, have there been any discussions regarding transitioning the domain name and allowing use of current content?
- 3. Who currently 'owns' the customer service call number for Bike Chattanooga? If Motivate, have there been any discussions regarding transitioning the number to the new operator?
- 4. If the City elects a new bike share operator, is there an expected transition date?
- 5. Will the City of Chattanooga be willing to consider a proposal requesting short-term operational funding provided to the new operator for the initial transition period?
- 6. Will the City be willing to connect the selected bike share operator with potential local corporate sponsors and/or foundations?
- 7. Can the City of Chattanooga provide a Profit/Loss Statement or Balance Sheet for the last year of bike share operations?
- 8. Are the current parts and tools (specifically the proprietary parts/tools) for bike share be included in the operational transition or will the new provider be expected to re-furnish all the system parts/tools?
- 1. Respondents cannot contact Motivate directly, all correspondence has to be sent to the Purchasing Department as stated in the solicitation.
- 2. CDOT owns the <u>bikechattanooga.com</u> web domain and is in the process of determining what content would remain with an operator change.
- 3. Motivate has a contract with Total Outsource Solutions out of Raliegh NC (http://www.tosystems.com, 1-800-413-3111). A new operator could negotiate with the call center to continue service with the same # and email, or develop an alternative customer service plan.
- 4. The City would like a Nov. 1, 2017 transition.
- 5. There are no City funds allocated to support bike share. There are grant funds available to support Bike Chattanooga through funding memberships (about \$40,000) and pay bike ambassadors (about \$15,000).
- 6. The City will support efforts by the operator to secure sponsor funding through introductions, letters of support, and attending meetings as requested by the operator.
- 7. The city does not have profit/loss statements from the current operators.
- 8. The city contends that all equipment purchased by the current operator to satisfy their obligations (parts, website, toolkits, furnishings, batteries, technical platforms, specialized equipment, etc.) is City property and stays with the system. An inventory with condition has been requested of the current operator.
