BACKGROUND: Due to damage from Hurricane Irma, the roof of the Caddyshack and Sebring Golf Club Pro Shop needs replaced. The Purchasing Department solicited for this service through an Invitation to Bid. On March 12, 2018, the Purchasing Department opened sealed bids for bid number 18-008, "Removal and Replacement of the Caddyshack/Sebring Golf Club Roof" (please see attached bid tabulation). Four bids were submitted for this solicitation:

Close Construction LLC:	\$86,175.00
Cobb Roofing, Inc.:	\$50,750.00
Robert E. White II Inc.:	\$56,971.82
Spires Contracting:	\$46,380.00

The cost of this service will be fully or partially reimbursed by insurance and FEMA.
