2. Buy America Certifications - It will be the submitting manufacturer's responsibility to certify that equipment meets the Buy America Certification requirement. 3. The water source heat pumps shall include Demand Control Ventilation with CO2 sensors in the spaces. Include a motorized damper for control on the outside air duct where it connects to the units.
4. The Water Source Heat Pump Closed Loop Piping Schematic on sheet M200 shows flow meters for the boiler and cooling tower loops. These are required but are just for local readout purposes.
5. The VFDs for pumps P-1 and P-2 shall control loop pressure.
6. Each WSHP unit shall have isolation valves.
